

Stölzle Wine Glass Contest

By participating in this promotion, each entrant fully and unconditionally agrees to accept these Official Rules as specified herein below:

1. Promotion

(a) How to enter the promotion and to win:

Three winners will be selected by RPWA and the winner will be announced on 10th March, 2020 at RPWA Facebook page.

The competition does not include any transportation or food costs occurred to and from the event nor during the event.

(b) Eligibility:

All Citizens of the European Union who reside in the European Union are eligible to take part in this promotion. You must be 18 years or older to be eligible for this promotion. Entries received after the stipulated time will not be eligible for entry. RPWA reserves the right to extend or shorten extend the promotion period from the stipulated date and time. No subscription to RPWA or any purchase or payment of any fee is required for participating. This offer cannot be clubbed with any other offer. The participant does not enter into any contractual or other legal relationship with RPWA or third parties.

2. Prizes

No disputes/correspondence of any kind whatsoever will be entertained with respect to the selection of the winners. The closing date is 10th March, 2020. Entries received after the closing time of the competition will no longer be considered regardless of the reason for the delay.

RPWA will notify winners through Facebook/email. Any further communication between RPWA and the winner will take place in private, individual messages. RPWA reserves the right to reject any entry, which is inappropriate, or has misleading or objectionable image/ image description or both.

The winners will need to collect their prizes at the event itself. The prize is awarded exclusively in the stated form. It cannot be exchanged for anything else or paid out in cash. The prize cannot be given to a third party or sold.

3. Choosing the winners

The winner selection will take place in private within the whole contest duration. All claims to the prize will become null and void if the winner does not respond to the notification of his/her prize within 4 days of notification.

4. Disqualification from the competition

RPWA is entitled to exclude individual entrants from the competition if justified reasons exist, such as violation of the terms and conditions of entrance, influencing the competition, manipulation etc. Participants, who are entered automatically, i.e. by bots or other technical means, will also be disqualified from the competition.

In the event of a reason for exclusion from the competition, prizes may be withdrawn retroactively and any prizes that have already been paid out or delivered reclaimed.
